BRIEF JOB SUMMARY: Assists Behavior and Enrichment Manager with implementation of behavior modification, enrichment, adoption and intake counseling for dogs and cats. Works as an Animal Care Specialist with both dogs and cats. Oversees canine Sleepover Program. Other duties as assigned.

Reports directly to the Behavior and Enrichment Manager (BEM).

Essential Job Functions: (Other duties may be assigned by the Operations Director per training and qualifications.)

Behavior/Enrichment Duties:

- 1. Compile historical information for completion of Adoption Summaries for all Fast Track Dogs.
- 2. Perform canine behavior evaluations in conformance with HOV policies and procedures in the cooperation and guidance of the Behavior and Enrichment Manager.
- 3. Perform dog introductions with HOV dogs in a timely manner.
- 4. Create and oversee dog play groups with appropriate dogs.
- 5. Organize group walks.
- 6. Communicate behavioral concerns and interventions to the BEM.
- 7. Ensure behavior plans are being followed in cooperation and guidance of the BEM.
- 8. Write Bios for adoptable dogs and obtains quality images of adoptable dogs.
- 9. Develop and implement individualized enrichment plans for all long stay animals in cooperation and guidance of the BEM.
- 10. Oversee the Canine Sleepover Program
- 11. Complete adopted Behavior Consult dogs call-backs
- 12. Performs behavior consults for HOV adopters and adoptable animals deemed 'Behavior Consult.'
- 13. Perform Initial Medical Exams for canines or felines with non-surgical requirements.

Training:

- 1. Work with BEM to implement training programs for HOV staff.
- 2. In conjunction with the Volunteer Manager and BEM, conduct training programs for HOV volunteers.

Animal Care Duties:

- 1. Performs ACS duties as needed
- 2. Supports other staff team members as needed
- 3. Responsible for communicating health and welfare concerns to the BEM or Shelter Vet Staff.
- 4. Performs intake exams, vaccinations and deworming on new dogs and cats coming into the shelter per HOV protocols.
- 5. Offers compassionate counseling for individuals surrendering a pet, while accurately documenting pertinent information according to HOV protocols.
- 6. Maintain positive customer relations and public visibility, and act as a professional ambassador for all public interfaces in a manner upholding the mission and goals of HOV.
- 7. Provide quality adoption counseling, including behavior consults and complete all relevant paperwork to standard.
- 8. Other duties as assigned.

Qualification Requirements: (To perform this job successfully, an individual must be able to perform each essential duty and task satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. Reasonable accommodations will be made to enable individuals with disabilities to perform the essential functions.)

- 1. High School education or GED
- 2. Must be able to lift a minimum of 50lbs
- 3. Must be able to work outdoors in all types of weather
- 4. Must be able to work comfortably with dogs and cats of all breeds and ages
- 5. Must be well versed in canine and feline behavior and safe animal handling
- 6. Must have a minimum of 2 years' experience in canine and feline behavior and safe animal handling
- 7. In in the process of obtaining Animal Behavior or Canine Training credentials (CTC, CCPDT- KA, CBCC-KA) Preferred.
- 8. Must be able to write and communicate effectively with staff, volunteers, and members of the community.
